6. **DISCUSSION OF NEW COMMITTEES.**


Director K. Thomas discussed new assigned committees. All committees were agreed on.

7. **REPORTS AND DISCUSSION OF OTHER MATTERS THAT MAY COME BEFORE THE BOARD.**


