Bill Blitch updated the Board of 5.325 Million in series 2012 Bonds that are outstanding with a 4% interest rate and on Oct. 1st they become callable, the maturity only goes up to 2025. In this case we can save after paying all the set bond sale there is a net savings of \$200,000 about a 3.75% value savings. Mr. Blitch will present a prepared official statement that will be ready to receive a motion at that time.
