Mr. Ortiz reported this was discussed last month where the applicant wants to surpass the 600 ft. Director Hulsey stated he spoke to Mr. McGinnis and was told there is already a lot out there and they were already flushing that line. The applicant told Director Hulsey he would go ahead and stop two lots before to avoid having to loop the line all the way around. Director Jarvis asked Mr. McGinnis as a clarification how many lots will be potential customers that would probably develop rapidly once water is available without including this developer's job. Mr. McGinnis stated there would be at least four lots. Director Jarvis then asked if the district is legal with fire hydrants if not will have to include it in the cost before approving. Mr. McGinnis said they will need to install a fire hydrant as well. Mr. Ortiz told Director Hulsey the developer would need to submit another set of plans to include the fire hydrant.

Director Hulsey made a motion to approve the extension over 600 ft for water service for lots within Horizon City Unit 9 and was seconded by Director Barton.
